Sub:-Promotion of MTS to the grade of Clerk on passing of Departmental Examination held on Oct 2016.



Further, the individuals who have not passed the typing test will be eligible for increment only after passing of the typing test and they will further not be considered for promotion to the grade of Auditor before they either pass the typing test or get exemption from the typing test.

If the individuals are drawing higher Grade Pay in same pay band by virtue of MACPS they will continue to draw the same grade pay (as per 6th CPC) and no fixation of pay will be applicable at this stage.


