
Subject: Furnishing of Quarterly Report QE 06/2017 to CIC: RTI Act 2005

The section 25 of the RTI Act 2005 enjoins upon the Central Information Commission to prepare an annual report to be laid before the Parliament. Accordingly a report in prescribed proforma (enclosed as Annexure A) is required to be submitted through online RTI portal on Quarterly basis to CIC.

2. 4. It may also be ensured that all the RTI application received in offline mode alongwith the disposal is upated on the RTI online portal.


