Sir,

Kind reference is invited to Cabinet Secretary's DO No. 1/48/8/2022-Cab. dated 8th November 2022, on the subject of mainstreaming of the logo and theme of India's Presidency of the Group of Twenty (G20). The aim of this was to both carry the message of G20 to the masses as well as to instil a sense of pride amongst the domestic populace.

2. In this regard, it has been seen that the response of the Ministries to the use of India's G20 logo has been uneven and therefore, G20 Secretariat would again request all Ministries, Departments, CPSUs to use the G20 logo as extensively as possible and explore proactively, avenues for further dissemination of the logo.

3. To ensure that, this is done with a whole-of-Government approach, as well as to encourage public participation in G20 events, the following additional suggestions are offered:

- a) Logo may be printed on salary slips of all Government of India employees.
- b) All advertisements that are being issued to have the G20 logo and theme.

- c) At G20 meeting venues, the Line Ministries could consider holding a *Jan Bhagidari* participatory side event a couple of days before or after the meeting to build a connect with the local population, build momentum and create a buzz in the run up to the event.
- d) Ministries may issue participatory certificates for *Jan Bhagidari* events to encourage public interest.
- e) Ministries, especially the Ministry of Environment, Forest and Climate Change, may explore the possibility of undertaking tree plantation drives, and set up G20 Parks in venue cities. This could be a *Jan Bhagidari* event undertaken with the involvement of the public.

4. In addition, all Ministries, especially Line Ministries dealing with G20 meetings are again requested to display India's G20 logo and theme in their office premises as hoardings, banners, standees, etc. to ensure greater visibility and awareness.

5. I would request all Ministries and other stakeholders to consider the above request positively at their end.
