

The result of SAS Part I Examination (CBT) May, 2023 held from 24.05.2023 to 26.05.2023 has been declared on 09.06.2023. As the result of the candidates whose provisional status have not been cleared by the concerned PCsDA/ CsDA, is kept 'Withheld', it is requested to expedite confirmation of clearance of provisional candidature by **16.06.2023**.

2. In case, the provisional status of the candidates is not cleared due to non-receipt of the service records from the previous Controllers, matter may be referred to the concerned Controllers **immediately** for verification of their credentials. On receipt of the confirmation, the candidature of the candidates may be recommended by Board of Officers for clearance of provisional status and forwarded to the HQrs. Office on **TOP PRIORITY** for declaration of the result.

3. Further, it has also been observed that the candidates are addressing their representations regarding examination matter to the e-mail address of AN-SAS Section of HQrs. Office directly, which is in contravention to the laid down provision. In this regard, it is clarified that keeping in view the time constraint involved during registration process of the examination, the said E-Mail address was provided to the candidates for resolving their issues promptly. Accordingly, instructions may be issued to all the candidates to send their representations, if any, through proper channel only.
