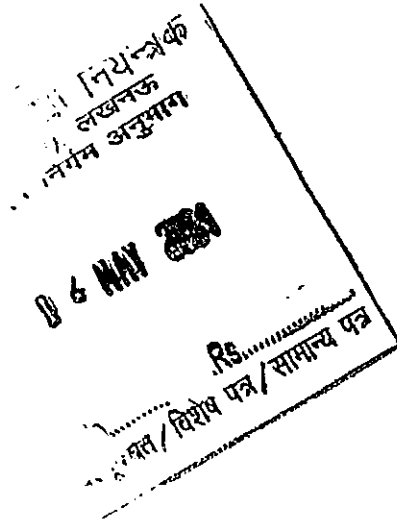

A Standing Committee Meeting on GeM was held on 06.04.2021 in MoD (Fin.), South Block, New Delhi.

2. During the meeting, it was stated that delayed payment of GeM bills is a cause of concern. Accordingly, it was decided that all CsDA must ensure timely payment to avoid the levying of 1% interest on monthly basis on delayed payment.
3. In this regard, Ministry of Finance, Department of Expenditure, Procurement Policy Division OM No. F.6/18/2019-PPD dated 03.07.2020 has already been circulated vide HQrs. letter No. IFA/109/Vol.II dated 17.07.2020 for compliance. Besides above, instructions have been issued from time to time for timely payment of GeM bills.
4. In view of the above, it is advised to sensitize the all concerned suitably to adhere with the prescribed time frame in order to avoid interest on delayed payment on GeM bills.
