Sir.

I am directed to convey the approval of competent authority regarding the abolishment of free electricity in the light of abolishment of Electricity Allowance vide Ministry of Finance (Department of Expenditure) Resolution No. 11-1/2016-IC dated 6th July, 2017.

- The abolition of electricity allowance will be effective from 01.07.2017 as per the above quoted resolution. However, amount paid for the period after 01.07.2017 as electricity allowance may be recovered.
