



ADDENDUM


1. The following additions are made at Para 2(a) under column Read in Gol/MoD Corrigendum No B/68628/Policy (Qtr)/24/ F/D(Q&C)/15 dated 21 Apr 2015 regarding charging of damages for unauthorised occupation of defence pool accommodation and recovery of licence fee when defence pool accommodation is allotted to ineligible persons/ organization/ private parties:-

"50 times charges of Garages & Servant quarters irrespective of type of quarters be levied as additional charge while calculating the Damage Rates of Rent, when allotted independent of the regular accommodation/hostel. This would be over and above the calculation of Damage Rate of Rent in multiples of LF, garden and other allied charges".
