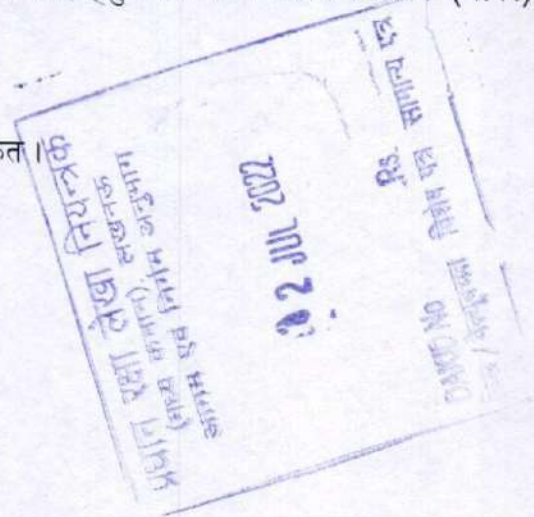


OFFICE MEMORANDUM
