
Subject: Provision of Medical and Dental Facilities to the R&AW personnel and their family members posted in North-Eastern Region, forward areas of J&K and Leh and SB Srinagar.

Sir,

I am directed to refer to this Ministry's letter No 20214/34/RAW/DGAFMS/DG-3A/21/2020/D(Medical) dated 07 Jan 2020 and to convey the sanction of the President to extend the provisions of medical and dental facilities from Military Hospitals to the personnel of R&AW and their family members posted in North-Eastern Region, forward areas of J&K and Leh and SB Srinagar and for a further period of two years with effect from 07.01.2022.

2. The treatment in Military Hospitals to the personnel of R&AW and their family members posted in North-Eastern Region, however, will be provided only when such treatment is not available in the civil hospitals functioning in the area.
3. The treatment in Military Hospitals to the personnel of R&AW and their family members posted in J&K, Leh and SB Srinagar, shall be provided without the condition of non-availability of treatment in civil hospitals.
4. This issues with the concurrence of the Ministry of Defence (Fin) vide their U.O No 231/AG/PD-2022 dated 4/8/2022 of RF NO. 3(7)/2008-AG/PD.
