

Subject: Selection of SAOs/AOs/AAOs to serve as faculty in OTI Gurugram .

It has been decided that names of volunteer SAOs/AOs/AAOs may be called for selection of training faculty for OTI, Gurugram for imparting training to the officers and staff. SAOs/AOs/AAOs who are selected as training faculty would be eligible for training allowance in accordance with the extant rules. The volunteers must have good skills and proven aptitude for training. Before appointment to the post of training faculty in OTI, Gurugram, the volunteer officers would have to undergo a screening test which would be conducted by a Screening Committee, constituted by HQs office.

- 2. It is accordingly requested that the names of volunteers amongst SAOs/AOs/AAOs in your offices may be provided as per the enclosed format (Annexure-'A') latest by 31.08.2022. Names of the volunteers who would be retiring up to August 2024 may not be forwarded. This circular may be given wide publicity.
- NIL report is also required.
- 4. While forwarding the names of volunteers, the Heads of offices concerned {PCDAs/CDAs/PIFAs/IFAs/PCA(Fys)/CDA(RTCs)} are requested to furnish their specific recommendations along with the APAR gradings for the last 3 years for consideration by the Screening Committee.
- 5. The under mentioned conditions for applying for the post of Faculty in Training Institutes, issued vide this office letter no. TD/3279/Policy/2017/part file dated 09.04.2021 as amendment No.11 to the Training and Development Policy 2019 (uploaded on CGDA Website), may also be kept in view while forwarding the names of volunteers for the post of faculty:-

Contd P-2.

- (i) A "cooling off period" 3 years would require to be completed for considering the candidature of officers for serving as faculty, who have earlier served/serving as faculty.
- (ii) A minimum stay of 2 years at present station or prescribed length of tenure for hard and tenure station would require to be completed by the volunteer officers before being eligible for the post of faculty in training centre.
- (iii) The officer applying for the post of faculty should not have applied for other panel for transfer to Bhutan/Tajikistan, J&k Region, North East Region, Andaman & Nicobar Islands etc.
- (iv) The officers applying for the post of faculty in Departmental Training Centre should have minimum residual service of 2 years as on 31.08.2022.
