Dear Sir,

As you are aware, Ministry of Skill Development and Entrepreneurship (MSDE) has been working to create an enabling and empowering eco-system to promote skilling and entrepreneurship across the country. Further, MSDE has been entrusted with the task of coordinating with all the stakeholders including Central Ministries. State Govts, Private Industries and organizations to have a standardized and integrated skilling framework.

- 2. There are around 20 Central Ministries / Departments including MSDE, that are implementing multiple skilling programmes under various namescatering to their sectoral/geographical focus to cope up with growing demand-supply mismatch of humanresources in respective sectors.
- 3. MSDE has taken several initiatives tof acilitate convergence in the various initiatives taken by the different stakeholders. Some measures include:
 - National Skills Qualifications Framework NSQF (2013) for standardization of Curriculum and Content.
 - Notification of Common Norms (2015) to bring about uniformity and standardization in pay-out for skill development training.
 - iii. National Council for Vocational Education and Training (2018) has been set up as an overarching regulator to ensure quality in the TVET space.
 - iv. Skill India Portal/ SMART Portal (2019) and the upcoming Skill India Portal 2.0 (www.skillindia.gov.in) for standardization of Input Quality anddata convergence.
 - v. ASEEM portal (2020) is a common skilled workforce directory facilitating both skilled manpower and employer. (This will be merged with SIP 2.0)
 - vi. National Apprenticeship Promotion Scheme (NAPS) launched in 2016, to promotethe apprenticeship programme in India.
- 4. It may be seen that MSDE's approach to convergence is based on the premise of standardization, unified but light touch regulation, data convergence, etc. We need to therefore work collectively for better convergence to achieve the objective of 'Skill India'.
- 5. In view of above, I would request your personal intervention in taking the agenda of convergence forward through the following suggestive line of action:
 - i. All Ministries/ Departments offering skill programmes to be on boarded on the Skill India Portal (at batch formation stage or even post-certification).

ii. Use of Skill India Logo, as well as logo of respective Ministry/ Department on certificates, along with QR code which leads to verifiability of certificate by the employers.

iii. Adhering to Common Normsas the upper limit for skilling programmes ofrespective

Ministries/Departments.

iv. Alignment of all skilling courses offered by Ministries/ Departments including non-funded courses of their affiliated/ partner organisations to NSQF to attain standardization across the Skilling ecosystem.

v. Ministries/ Departments must encourage PSUs to engage more & more Apprentices. They should also encourage the PSUs or other autonomous bodies to incorporate the requirement of

'skilled manpower' in their contracts.

vi. Onboarding of recognized organizations/ autonomous bodies of respective Ministries/Department as Awarding and Assessment Body aligned with NCVET norms.

vii. Cross utilization of available resources across schemes including infrastructure, training content. trainers, assessors, question bank, etc. It may please be noted that DGT (through NIMI) and all SSCs have put large amount of content copyright free on the net.

viii. Support District Skill Committees established at district level in preparation of an integrated

District Skill Development Plan.

ix. All Ministries implementing Skill Development Schemes may leverage the utility of ASEEM portal which is now being subsumed under the improved Skill India Portal 2.0. For Ministries having their own Job portal, we strongly suggest using two-way APIs to share data dynamically. so that student gets more chances/ opportunities.

x. Sharing of knowledge products regarding skill gaps, job projections etc. to aid in overall

planning.

I will request you to kindly share the action taken by your Ministry in this regard and looking forward to your intervention in making 'Skill India Mission' successful.
