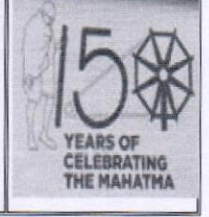

The undersigned is directed to state that the issue regarding appointment/recruitment of 17 temporary staff (earlier employed through outsourcing) on regular basis to the post of MTS in the Pay Matrix Level 1 in various benches of Armed Forces Tribunal by Chairperson of the AFT without following the procedure for direct recruitment mentioned in para 7 of the SRO 2 (E) dated 10-06-2013 was raised by office of the PCDA, New Delhi.
