



**CIRCULAR**

**Subject: Filling up of the post of Director, Arun Jaitley National Institute of Financial Management, Faridabad (Haryana) by deputation/re-employment/short-term contract-reg.**

It is proposed to fill up the post of Director, Arun Jaitley National Institute of Financial Management, Faridabad (Haryana), an autonomous body under the administrative control of the Ministry of Finance, Department of Expenditure by deputation/re-employment/short-term contract. The post carries the pay scale of Level-16 in the Pay Matrix [in 7<sup>th</sup> CPC scale] plus various allowances at Central Government rates. Residential accommodation will be provided at the Institute's campus.

2. Eligibility conditions for appointment are as follows:

(A) Officers belonging to Indian Audit & Accounts Service, Indian Civil Accounts Service, Indian Cost Accounts Service, Indian Defence Accounts Service, Indian P&T Accounts and Finance Service and Indian Railways Accounts Service with one year regular service in HAG Grade or with 4(four) years regular service in SAG.

Note (i): Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization shall ordinarily not exceed five years.

Note (ii): Appointment by re-employment would be permissible up to 65 years of age or 5 years whichever is earlier.


(B) The crucial date for determining the eligibility service shall be 11.07.2023. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 58 years as on the closing date of receipt of applications. The applicants who have crossed this age limit shall be considered only on re-employment basis.

3. The terms and conditions for appointment on deputation/re-employment/short-term contract will be regulated in accordance with the Central Government rules.

4. It is requested that the vacancy circular may be given wider publicity amongst the eligible officers. Applications in triplicate in the prescribed proforma (Annexure II) of suitable & eligible officers, who are willing to be considered for appointment against the said post on deputation/Re-employment/Short-term contract basis and whose services could be spared by the cadre immediately may kindly be forwarded along with CR dossiers, Integrity Certificate, Vigilance Clearance Certificate, No Penalty Certificate in the last ten years through proper channel to Under Secretary(Admn.I), Department of Expenditure, Room No. 225-E, North Block, New Delhi-110001, so as to reach within 28 days from the date of publication of this advertisement in the Employment News. Incomplete application will not be considered.
