विषय: Bunching increment for the pay stages which have got bunched after grant of entry pay Rs. 13350+4800/- to AAOs of the DAD.

Please find enclosed a copy of HQrs Office letter no. AN/XIV/7th CPC/Corr./Vol-II/Bunching AAO dated 23.11.2022 regarding above subject matter.

2. In above HQrs letter, it is intimated by the case regarding grant of bunching increment for the pay stages which have got bunched after grant of entry pay Rs. 13350+4800/- to AAOs of the DAD has been turned down and not agreed to by the Ministry of Finance, Dept. of Expenditure / Ministry of Defence (Fin.). The Dept. of Expenditure has made the following observation:-

"...As per CCS (RP) Rules 2008, the revised pay of AAOs as on 01.01.2006 will be fixed under Rule 7 of CCS (RP) Rules 2008 i.e. by multiplying their basic pay as on 31.12.2005 in their pre-revised scale with factor 1.86 (rounded off to next Rs.10) and thereafter to add the upgraded Grade Pay Rs. 4800 and if the resultant figure (i.e. revised pay in pay band+ Grade pay) is less than the entry pay of AAO of GP Rs. 4800 i.e. Rs. 18150 then AAOs may be granted the minimum entry pay of Rs.18150 w.e.f. 01.01.2006. **The bunching benefit on entry pay of Rs. 18150 as proposed CGDA/MoD is not in order and hence not agreed to**".

In view of the above it is requested that the same may be brought to notice of all concerned and dealt the related cases accordingly.

The case regarding grant of bunching increment for the pay stages which have got bunched after grant of entry pay Rs. 13350+4800/- to AAOs of the DAD was under consideration with the Min. of Finance, Dept. of Expenditure / Ministry of Defence (Fin.).

2. It is intimated that the case has been turned down and not agreed to by the Ministry of Finance, Dept. of Expenditure / Ministry of Defence (Fin.). The Dept. of Expenditure has made the following observation:-

"...As per CCS (RP) Rules 2008, the revised pay of AAOs as on 01.01.2006 will be fixed under Rule 7 of CCS (RP) Rules 2008 i.e. by multiplying their basic pay as on 31.12.2005 in their pre-revised scale with factor 1.86 (rounded off to next Rs. 10) and thereafter to add the upgraded Grade Pay Rs. 4800 and if the resultant figure (i.e. revised pay in Pay Band + Grade Pay) is less than the entry pay of AAO of GP Rs. 4800 i.e. Rs. 18150, then AAOs may be granted the minimum entry pay of Rs. 18150 w.e.f. 01.01.2006. The bunching benefit on Entry pay of Rs. 18150 as proposed CGDA/MOD, is not in order and hence not agreed to."
