




**Subject: -Discontinuation of Book Adjustment i/r/o PLI premia collected through salary deduction from Other Ministries. -reg.**

Kindly refer to your office UO No. 1 (8)/2022/TA/Comp. No. 10850/116 dated 20.03.2023 wherein it was stated that the existing procedure of discontinuance of Book Adjustment is to be reviewed. The matter was examined at this office and it is to convey that the earlier procedure of Book Adjustment shall continue.

Regarding payment of GST on PLI premiums recovered by Non-Postal PAOs/DDOs using centralized GSTIN for PLI, it is intimated that the matter is under discussion with the GST Authorities. Decision in this regard will be conveyed in due course of time.
