1. A non-lapsable dedicated 'Agniveer Corpus Fund-Seva Nidhi Package' will be created in the interest bearing Section of the Public Account. The fund will be administered and maintained by Ministry of Defence.
2. Each Agniveer shall contribute 30% of his monthly 'Consolidated Pay' to the 'Agniveer Corpus Fund-Seva Nidhi Package'. The Government will provide matching contribution towards the fund. The following transaction will be operated in the instant case:

6. In case of death or disability:

a. Death during engagement period on bonafide duty:

In addition to *Pay* and ex-gratia payable from the concerned service functional head, balances under the Agniveer Corpus Fund – Seva Nidhi Package will be payable. In this case entries at Point 4 above will be made.

7. Audit of the Agniveer Corpus Fund:

Transaction related to Agniveer Corpus fund shall be subject to statutory audit by the Director General of Audit, Defence Services/Comptroller and Auditor General of India. The Accounts shall also be subject to internal Audit by DAD.
