I am writing this DO letter regarding provision of <u>making direct payment in bank account of the GPF Subscribers</u>. In this regard it is intimated that a lot of instances have come to the notice of this office wherein the amount of GPF Final Settlement/ Final Withdrawal of the subscriber has been credited by this office to the Public Fund Account of the unit, but the same is not disbursed to the subscriber in time, for variety of reasons. The units also insist upon that the payment be released to the Public Fund Account of the unit. This office has also received complaints on Toll free number that the cashiers of the unit sometimes manipulates the money available with them and make eventual payment to the subscriber after considerable delay.

2. In this context, I would like to bring to your kind notice that as per the Government of India policy, every government employee is to get his/her salary directly in personal bank account and also all other payments are required to be directly paid in the bank account of the employee. Ministry of Finance OM No.F.No.3(2)(1)/2016/TA/R&P Rules/Amendment/443 dated 12.05.2017 and HQrs office letter No.A/III/12157/ECS/Comm dated 09.06.2017 are referred in this regard (copies enclosed).

3. In order to strengthen/implement the government policy and to curb such instances of delayed disbursement of payment by units to the subscriber and also to ensure timely payment of the GPF Assets to the subscribers, all DDP Controllers/Pay Audit Officers are requested to ensure that the bank account along with all details. (IFS Code etc.) of the subscriber may be provided on the Contingent Bill. An

endorsement in this regard may also be made by the DDP Controller offices/Pay Audit Officer, that the bank account details viz. subscriber's bank account number, Bank Name and address with IFS Code have been provided on the bill.

- 4. In this regard, it has been decided that from 1st March 2019, this office will only accept the FS/FW bills wherein bank details of subscriber and endorsement by DDP/PAO has been provided. The FS/FW bills, received without the bank account details of the subscriber and endorsement by DDP/PAO, will be returned without any action.
- This may be brought to the notice of all concerned.

G.S.R. 412 (E) dated 27-04-2017 (copy enclosed), it has been directed that all payments to Government servants, including salary payments, shall be made by electronically signed payment advices for direct credit to their bank accounts, subject to availability of banking facility.

Provided that a one-time relaxation may be granted for payment by other recognized modes in cases of hardship where the reasons are duly approved by the Head of Department and Financial Advisor.

3. In view of the above, it is requested that all payments to Government servants including salary payments may be made by electronically signed payment advices for direct credit to their bank accounts.

Provided that a one-time relaxation may be granted for payment by other recognized modes in cases of hardship where the reasons are duly approved by the Head of Department and Financial Adviser.
