Consequent upon sanction issued by GoI, Ministry of Finance, Deptt. of Expenditure vide OM No. F No. 25-2/2017-IC/E.III (ii) dated 06.11.2020, circulated vide HQrs Office circular No. AN/XIV/14162/7th CPC/VoI-II dated 13.11.2020; approval has been accorded by the competent authority for grant of Non-Functional Upgradation (NFU) in Level-9 of Pay Matrix of the 7th CPC in respect of the AAOs listed in Annexure 'A' w.e.f. the dates mentioned against their name.

- 2.  - (iv) Option of pay fixation may be exercised within one month of issue of this order.
 - (v) This supercedes all earlier Part-II Office order issued on account of MACP granted after 01.01.2016 in Pay Matrix Level-9, if any.
 - (vi) In the event of any erroneous grant of NFU noticed at later stage, officers would be liable to refund the difference of pay and allowances to the department.
