विषय: Implementation of recommendation of 7th CPC-Para 11.12.140-Grant of grade of Rs. 5400 (PB-2) i.e. Level 9 of Pay Matrix in case of Assistant Accounts Officer of Defence Accounts Department of Ministry of Defence.

Consequent upon sanction issued by GoI, Ministry of Finance, Deptt. of Expenditure vide OM No. F No. 25-2/2017-IC/E.III (ii) dated 06.11.2020, circulated vide HQrs Office circular No. AN/XIV/14162/7th CPC/Vol-II dated 13.11.2020; approval has been accorded by the competent authority for grant of Non-Functional Upgradation (NFU) in level-09 of Pay Matrix of the 7th CPC in respect of Shri Nitin Kumar Mishra, Asstt. Accounts Officer/8340762 w.e.f. 19.11.2022.

2. In accordance with the ibid OM the revised pay scale of the post of Assistant Accounts Officer in the Defence Accounts Department would be in Level-8 of the Pay Matrix and level-9 on completion of 4 years in grade pay of 4800 (PB-2)/Level 8. This is Non-Functional Upgradation (NFU), which is subject to the following terms and conditions.

- (i) Benefits of Pay Fixation as per Rule 13 of CCS (Revised pay) Rules 2016 shall be available at the time of grant of NFU to Shri Nitin Kumar Mishra, AAO/8340762
- (ii) After the grant of NFU to Shri Nitin Kumar Mishra, AAO/8340762 in pay level-9 and their pay fixation under Rule 13 of CCS (Revised pay) Rules 2016, there will be no further fixation on promotion to the post of Accounts Officer in Pay Level-9.
- (iii) NFU will be reckoned for Financial Upgradation under MACP Scheme.
- (iv) Option of pay fixation may be exercised within one month of issue of this order.
- (v) In the event of any erroneous grant of NFU noticed at later stage, the officer would be liable to refund the difference of pay and allowances to the department.
