प्रधान मुख्य आयकर आयुक्त कार्यालय द्वारा निर्धारित, कैलेण्डर वर्ष 2023 के दौरान रखी जाने वाली वाली छुट्टियाँ इस कार्यालय आदेश भाग-॥ के अनुलग्नक - ॥ के अनुसार होंगी। उक्त छुट्टियों के अलावा प्रत्येक कार्मिक अनुलनक - ॥ में वर्णित प्रतिबंधित छुट्टियों की सूची में से किन्हीं दो छुट्टियों का उपयोग कर सकता है।

As decided by the Pr. Chief Commissioner of Income Tax, Lucknow the holidays, as specified in the Annexure - 1' to this part-II O.O. will be observed during the year 2023. In addition, each employee will also be allowed to avail himself/herself of any two Restricted Holidays to be chosen by him/her out of the list of Restricted Holidays specified at Annexure-II.

No substitute holiday should be allowed if any of the festival holidays, initially declared, subsequently happens to fall on a weekly off or any other non-working day or in the event of more than one festival falling on the same day.

If there is any change in the date of any holiday/restricted holiday, it will be published through PCDA (CC) Lucknow website.

Officers/Staff presently at deputation or on attachment with other establishments will observe the holidays published by their respective establishment of deputation or attachment.
