Subject:-Implementation of recommendation of 7th CPC-Para 11.12.140 - Grant of Grade of Rs. 5400 (PB 2) i.e. Level 9 of Pay Matrix in case of Assistant Accounts Officer of Defence Accounts Department of Ministry of Defence.

Consequent upon sanction issued by GOI, Ministry of Finance, Dept of Expenditure vide OM no. F.No.-25-2/2017-IC/E III(ii) dated 06.11.2020, circulated vide Hqrs circular no. AN/XIV/14162/7thCPC/Vol-II dated 13.11.2020, approval has been accorded by the competent authority for grant of Non-Functional Upgradation (NFU) in respect of AAOs mentioned in Annexure 'A' in Level-9 of pay matrix of the 7th CPC w.e.f. the dates mentioned against their name.

- 2. In accordance with the ibid OM the revised pay scale of the post of Assistant Accounts Officer in the Defence Accounts department would be in Level 8 of the Pay Matrix and Level 9 on completion of 4 years in grade Pay of Rs. 4800 (PB-2)/Level-8. This is a Non Functional Upgradation (NFU), which is subject to the following terms & conditions:-
 - (i) Benefits of Pay fixation as per rule 13 of CCS (revised pay) Rules 2016 shall be available at the time of grant of NFU to AAOs.
 - (ii) After the grant of NFU to AAOs in pay level 9 and their fixation under rule 13 of CCS rules 2016, there will be no further fixation on promotion to the post of Accounts Officer in Pay level-9.
 - (iii) NFU will be reckoned for financial upgradation under MACP Scheme.
 - (iv) Option of pay fixation may be exercised within one month of issue of this order.
 - (v) This supercedes all earlier Part II Office Order issued on account of MACP granted after 01.01.2016 in Pay Matrix Level-9 if any.
