

 - (d) HQ CGDA, Ulan Batar Road, Delhi Cantt UO Note No AT/III/187/VI CPC/ MACP-V/E-3054 dt 03 May 2023.
2. In regards to your letter u/r at para 1 (a) above, the fwg essential imperatives are appraised herewith :-

(a) Proposal for Counting the prior Service rendered by DCEs in lieu of Combatants had been taken up with DoP&T (Est D) vide Case File No B/015198/ACP/EME Civ-2 and the provisions of AI 188/66 and 151/67 for employment of Civilian in lieu of Combatants had been appraised.

(b) Vide Note 69 on case No Dy No 1362985/19/CR/ F/No B/15198/ACP/EME Civ (C-4) of M/o Defence dt 20 Mar 2019 DoP&T (Estt D) had very unambiguously communicated the fwg (copy enclosed) :-

"12. xxx, as informed by the MoD that service rendered in lieu of combatant basis is not counted for the purpose of promotion, hence DoP&T is of the view that the service which is not counted for the purpose of promotion as in the present case, cannot be counted for MACP purpose.

13. In view of the above, if approved, we may express our inability to accede to the request of MoD to count the service rendered in Lieu of combatants basis for the purpose of MACP benefits."

3. The aforesaid case file was returned to this Dte vide D (O-II) Dy No 636-F/ D (O-II) dt 12 Apr 2019.

4. Consequently, the following clarification have been rendered to the environment as well as EME Records by this Dte :-

(a) Dte Gen of EME (Civ) lettr No B/15198/ACP/EME Civ (C-4) dt 19 Jun 2019 where in it was promulgated that:-
