


While dealing with the proposals of various procurement and non-procurement powers under the revised Table 'B' of RMES issued by Ministry of Defence vide their letter No.16(04)/2023/DMA/Works-III dt 24/03/2023, issues like administrative sanction of Medical claims exceeding Rs 5.00 lakh has also been received at one of the IFA(Works) office for concurrence.

2. Please refer to CGDA letter No AN/14/19015/Govt Orders/TA/DA/LTC/Med/2016 dt 16/01/2017 vide which Ministry of Health and Family Welfare, Dept of Health and Family welfare letter bearing No S.11011/20/2014-CGHS(P)/EHSS dt 23/11/2016 was circulated. The ibid letter of Ministry of Health and Family Welfare mentions that cases involving payment exceeding Rs 5,00,000 (Rupees 5 lakhs only) as per prescribed rate list should be settled in consultation with the Internal Finance Division of the concerned Department/Ministries.

3. In light of the ibid Ministry of Health and Family welfare letter dt 23/11/2016, Medical cases exceeding Rs 5 lakhs as per prescribed rate list should be sanctioned by Head of the Department in consultation with IFA. Recently, IFA System has been implemented in the MES Organization, therefore, the Medical bills exceeding Rs 5 lakhs in respect of the officers and staff of MES Estt. may be sanctioned by Head of Department i.e E-in-C in consultation with the PIFA (Q&M). Further, medical claims exceeding Rs 5.00 lakhs in respect of MES Officers/staff posted in DCWE, HQ DRDO may be sanctioned by Head of the Department at DRDO HQ in consultation with IFA R&D, New Delhi.

4. All IFA (Works) functioning under your administrative jurisdiction may please be intimated accordingly.
