Subject: - Merger and re-designation of various common category posts as per 6<sup>th</sup> CPC recommendations-Reg.

Sir,

The proposal regarding re-designation of various posts in Defence Establishments consequent upon their merger as per 6<sup>th</sup> CPC recommendations has been under examination of the Government for quite some time.

2. A Committee constituted in the Department of Expenditure for deciding upon the common designation to the posts under question has considered the proposal. On the basis of the recommendations of the committee, Ministry of Finance, Deptt. of Expenditure has approved the following common designations of various cadres, as per their U.O. No. 10 (6)/E.III.B/2012 dated 12<sup>th</sup> February 2013 :-
