
Reference : Your office letter No.Pay/II/Tech/Misc dated 19.09.2022 & 03.03.2023.

The issues raised through above cited communication have been examined and following are stated:

(a) The issue regarding redesignation of Electrician as HS-I issued by DGS&T vide its letter dated 18.07.1985 by not following MoD letter No.3819/DS(O&M)/civ-1/84 dated 15.10.1984, has been taken up with DGS&T for their examination and issue of necessary clarification. The outcome of the same shall be intimated as and when the same is clarified by the DGS&T.

(b) As regards transfer to lower post under FR 15 (a), DoPT vide its OM No. 16/4/2012-Pay-I dated 05.11.2012 (Copy enclosed) clearly states that "on transfer to the lower post/scale under FR 15 (a), the pay of a Government servant holding a post on regular basis will be fixed at a stage equal to the pay drawn by him in the higher grade. If no such stage is available, the pay will be fixed at the stage next below the pay drawn by him in the higher post and the difference may be granted as personal pay to be absorbed in future increments". It is therefore requested to follow the provisions laid down in DoPT OM dated 05.11.2012.
