
Subject: Grant of 3rd MACP to the Grade Pay of Rs. 4600/-(Level-7) in r/o JEs.

3. The above information in respect of each case dealt by your office regarding the JEs in the select panel may please be forwarded **latest by 15th March, 2023**.



Please refer Appx "B" to above letter vide which 3rd MACPs to some of JEs were granted by your Hqrs. JEs under the Administrative control of HQ, CE, SC, Pune at sl.no8 to 13 were granted 3rd MACPs. This office has received three service books of under mentioned JEs for fixation of pay on 3rd MACP.

- i) Shri N Pandian, JE (sl.no.8)
- ii) Shri K. Prasad, JE(Sl. No.11)
- iii) Shri K. Ramachandraiah, JE(Sl.No.13)

On verification of the service books of the above Officers, it has been observed that these Officers were appointed in MES Industrial Establishment during the year 1982 to 1987 and granted two promotions in Industrial Cadre. Their promotion to the Post of JE is to be treated as 3rd Promotion in their service. Hence it was observed that grant of 3rd MACP is not in accordance with the extant orders of DoPT. As such this office has not approved the pay fixation and returned the service books to HQ, CE, SC, Pune.

2. As per the Appx "B" some of the JEs in other commands have also recruited during the years 1987 to 1988, they might have also been granted two promotions in Industrial Cadre and then promoted to the post of JE on similar lines. This is for information and for verification of their service details to ascertain, whether they are entitled for 3rd MACP or otherwise.

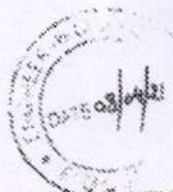

GROUP 'B' NON GAZETTED OFFICERS

- 1 Further to this HQ letter even No. dated 25 Aug 2020
- 2 Under the provisions of Govt of India, DoP&T letter No 35034/3/2008-Estt(D) dated 19 May 2008, and 35034/3/2015-Estt. (D) dt 22 Oct 2019, the Non Gazetted Gp B Officers listed at Appx 'A' to 'D' to this letter have been approved by the Competent Authority for 1st/2nd/3rd financial up gradation under MACP Scheme in the higher grade pay from the dates mentioned against each
- 3 Although every care has been taken by the Departmental Screening Committee (DSC) for verification of documents, still it is requested that the same may be rechecked with the service records of the officer before actual grant of MACP benefits to the officer. Before placing selected officers in the higher grade pay it should be verified and ensured that the officer has not refused regular promotion and is not debarred for regular promotion for any reason. Further, it should be confirmed before placing the selected officers in higher grade pay, that financial up gradation under ACP Scheme (old) granted, if any after 01 Sep 2008 shall be withdrawn.
- 4 Before placing the officer in the higher grade pay it shall be ensured that on effective date -
 - (a) The officer was not under suspension
 - (b) No charge sheet has been issued to the officer and no disciplinary proceedings were pending against him
 - (c) No prosecution for a criminal charge was pending against him.
 - (d) If the officer is under penalty period then the upgradation will be given only on expiry of the penalty period.
- 5 The officer is required to exercise his option in terms of fundamental Rule 22 within one month from the date of publication of panel
- 6 List of officers who have not been granted MACPS reasons mentioned against their names is attached as per Appx 'X' and list of persons who are not eligible for grant of MACP are attached as Appx 'Y'
- 7 All commands are requested to fwd duly completed board for next MACP to Gp 'B' Non Gazetted officers to this HQ by 30 May 2021, so that it can be put up to next DSC for considering for grant of MACP.
