Subject: Complaint regarding pay scale of Electrician (MV) SK

Reference: This HQrs office letter of even number dated 05.09.2022.

In above regard, it is to be informed that the issue raised vide the above cited letter has been examined in this HQrs office in consultation with the PCsDA/CsDA and the following has emerged:

(A) It has been clarified by ST Branch of HQ NC vide letter No. 1659/7/ST-12(Civ) dt. 23.04.2022 (copy enclosed) that correct pay scale and the restructuring of cadre of Artisan Staff in Def. Estt., in modification with recommendation of 5th CPC by Gol, MoD, the post of Electrician (MV) was upgraded from Skill Grade to Skill Grade -I vide Dte Gen of Sup. and IHQ of MoD (Army) letter No. 31350/A/Q/ST-12(Civ) dt. 18.07.1985 {para 3(a) and para 8(h)} (copy enclosed). Further, the pay scale of Electrician (MV) was granted on the basis of Recruitment Rules as applicable at the time of appointment of candidates.

(B) Further, as per Gol, MoD letter No. 11(1)/2002/D/(Civ-I) dt. 20.05.2003 (copy enclosed), it was inter-alia stipulated that all trades (after restructuring shall be classified as skilled (including left out trades)) in the Industrial as well as non-Industrial Estt. were modified in the following inter-grade ratio:-

- i. Skilled 3050-4590 : 45%
- ii. Highly Skilled 4000-6000 : 55%
- iii. Master Craftsman 4500-7000 : 25% of the Highly skilled grade post will be placed in the grade of the Master Craftsman. They will not be a part of the hierarchy.

(C) Based on the above letter DG S&T QMG IHQ New Delhi issued letter No. 78503/1/Q/ST-12 (Civ) dt. 20.06.2014 (copy enclosed) circulated HQrs directions contained in the MoD letter dt. 20.05.2003 to all commands for further action at their end.

(D) The above makes it quite evident that the pay scale of Electrician(MV) SK in Civ GT units under DGMT are correct.



(E) Further, the DG S&T QMG IHQ MoD (Army) New Delhi letter No. 78403/2/Q/ST-12(Civ) dt. 22.11.2021 addressed to Sh. Jeevan Kumar, has clearly stated that post of Electrician (MV) is authorised in Corps of EME and not in ASC and stipulated that as per various SROs the pay scale admissible to Electrician ASC Civ GT units are correct.
