



Sub: Extension of ban period of six firms debarred from doing business with MoD -reg.

Department of Defence Production (DDP), with the approval of the Competent Authority, had decided to debar the following six firms from doing business with Ministry of Defence for a period of ten years. Accordingly, instruction to this effect were issued vide MoD/D(Vig) ID Note No. 31013/4/2008/D(Vig) dated 11.04.2012:

2. Directorate of Ordnance (C&S)/DDP vide Orders dated 27.10.2023 & 02.11.2023, with the approval of Competent Authority, has extended the ban period of the above mentioned firms for 3 years w.e.f. 11.04.2022.
