Subject: Transfer Establishment: DAD.

Reference: This office letter no. even dated 24/3/2023.

To tide over acute shortages and for better management of manpower in the Department, this office has categorized some stations as 'Special stations' and 'Deficient stations' and issued instructions/guidelines for posting of officials at these stations as contained in this office letter referred to above. In order to further strengthen this system it has been decided to add more clauses in the guidelines for transfer/posting of officials. These are as under:

- After completion of prescribed tenure at 'Deficient stations', the officials will be posted to their choice stations as per their APAR grading i.e. higher the APAR, the chances of posting to first choice will be more.
- Officials posted to 'Deficient stations' will have to complete physical stay of 2 years and eight months or 32 months at the station to become eligible to apply for repatriation to one of their choice stations.
- Keeping in view that seniority has been the basis for posting to 'Deficient Stations', any officials who would have served earlier at 'Deficient Station'; his/her name will be placed below the name of individuals in the seniority list who have never served at these stations and as per number of stints served at 'Deficient stations' i.e. once served, twice served etc.
